PARTICIPATION AGREEMENT

I hereby represent and warrant to Indiana Primetime Sports that I have full legal power and authority to complete this registration on behalf of my child (under the age of 18), including full authority to make use of the credit or debit card to which registration fees will be charged. I hereby represent and warrant that, in compliance with the Children's Online Privacy Protection Act (COPPA), I am over thirteen (13) years of age, and that if I am registering a child under fourteen (14) years of age I am the parent and legal guardian of such child, and do hereby consent to the collection of such child's personal information by Indiana Primetime Sports.

RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

I knowingly assume the risk of participation on behalf of my child and hereby voluntarily assume all risks of loss, damage or injury, including paralysis or death, that may be sustained by my child while participating in any Indiana Primetime Sports programs, including but not limited to any loss, damage or injury caused as a result of or by the negligence of Indiana Primetime Sports and its agents, servants, employees and licensees. I acknowledge that it is my responsibility to provide medical insurance for my child to cover any injury resulting from my child's participation in any Indiana

Primetime Sports program. By signing below, I stipulate that my child has no injuries or other medical conditions which would keep my child from participating in any Indiana Primetime Sports programs.

I hereby agree to indemnify and hold Indiana Primetime Sports, its agents, servants, employees, and licensees harmless from and against any and all claims, costs, damages, losses, liabilities and expenses (including attorneys' fees and costs) arising out of or in connection with my child's participation in any Indiana Primetime Sports programs.
